

Scotland's Census 2021 – Topic Consultation

Background and update

National Records of Scotland is planning to conduct a census in 2021.

Scotland's Census 2021 will build on previous censuses and will be designed and managed in Scotland, to best meet the needs of its users. It will be conducted primarily online but will offer support and alternative routes of completion where required. It will aim to make best use of technology, digital services and other existing data.

Scotland's Census is the only reliable source of detailed information for a variety of characteristics of the people of Scotland. A huge amount of data is made available free of charge and we know that many individuals and organisations across Scotland use data from previous censuses to inform a variety of decisions.

But a lot can change in the 10 years between each census. Scotland in 2021 may be a very different place from 2011 so the information collected may need to change too. That is why NRS is currently consulting on the topics which should be asked in the next census to ensure that the information collected meets users' needs. It is all about better statistics to make better decisions.

Topic consultation open until 15 January 2016 - to understand user needs, a consultation on the <u>topics</u> to be included in the 2021 questionnaire is now open. Following the consultation, NRS will publish a response detailing the results and outlining a range of activity and further engagement to shape the detailed plans.

The topic consultation seeks on users' information requirements at topic level rather than the detailed questions that should be asked on the census questionnaire. The detail of the content of the questionnaires will only be finalised after a comprehensive programme of research, testing and further discussion with users.

Views and detailed information is requested on the specific topics noted below but any topics suggested in response to the consultation will be considered by NRS.

The topic consultation seeks views on:

- Strength of user need purpose
- Need for small geographies or populations
- · Requirement for UK comparability
- Requirement for consistency over time
- Need for multivariate analysis
- Suitability of alternative sources
- · Meeting user needs

Some example responses

Strength of user need / purpose:

"information on X is crucial to inform the spending on housing provision in town Y; grant allocations amounting to £Z were based on the projections made using this data"

"we use X data to assess the labour market activities of people with a long-term illness or disability, and to determine where policies should be targeted to help people overcome this potential barrier to work"

"the ability to compare information on how people travel to work or place of study and how the length of their journey has changed over time is essential to inform planning for future transport systems"

Need for small geographies or populations:

"fine geographical detail (output area data) is needed for transport modelling/planning"

"although some of the groups are small, they form key minority groups whose needs need to be accurately assessed if planning for language and other support services is to be effectively undertaken"

Requirement for UK comparability:

"we undertake comparative research and analysis of local labour markets across the UK and so having labour market information available on a consistent basis through the UK is essential to enable valid comparisons to be drawn"
